Bialsky also factors in Dr. Cantu's conclusion that Solomon's cognitive impairments will likely worsen to the point that he will require daily living assistance. As noted above, an expert can rely upon the opinions of other disclosed experts when conducting their own analysis. It was further stated that Next, the NCAA argues that Bialsky's methodology is unreliable because he did not examine each and every one of Solomon's medical records. But the NCAA fails to point out any particular medical record that it thinks would have made a difference. And to the extent it can point to any, the NCAA may raise it on cross-examination. The Court denied the motion.

See *Bogle-Assegai*, 470 F.3d at 504 (HN10 absent compelling reason this Court will not consider new arguments on appeal).
